

200 YARD SMALLBORE PRONE MATCH

At Reading Rifle and Revolver

DATE: Sunday, September 23, 2012

FIRST SHOT: 0900

OPEN TO: Everyone.

PLACE: Reading Rifle and Revolver Club Range, Haverhill St., Reading MA. (From I-95 (Rt. 128) N or S, take exit 40, go towards North Reading on Haverhill St. for one mile, north. Turn Right at the traffic light. Bear right away from the ice rink and onto Range Road. Phone # on day of match, only, is (781) 942-1027)

ENTRY PROCEDURE: Entry Fee is \$10. This match is not NRA approved. Send check for \$15/shooter, name, address, and phone number with a check payable to Reading R&R Match Account, to: Geoff Neiley, 338 Haverhill Street, North Reading, MA 01864. Entries will be accepted on the day of the match as space allows. Address questions to the above at 978-664-5092, or bneiley@gmail.com.

PIT SERVICE: Not Provided. Competitors will pull targets or may bring a puller. Competitors may hire any available pullers. Competitors with physical problems pulling targets may request a puller with their advance entry – No Guarantees.

RIFLE / RULES: .22lr ONLY (subsonic ammunition is highly recommended). There will be separate classes for IRON SIGHT, ANY SIGHT and F-CLASS. NRA Smallbore Prone rules will govern, supplemented by applicable NRA Highpower rules. Violation of Reading's "muzzles down" rule will result in immediate disqualification from the match.

ELEVATION NOTE: You will need about 27 +/- minutes over your 50 yard zero to be on paper at 200 yards. Coaching will be allowed during sighters on the first match until competitors is on paper.

COMPETITOR CLASSIFICATIONS: OPEN

COURSE OF FIRE:

Match 1: 200 yards, A-21 Target. Unlimited sighters plus 20 shots for record in a block time of 30 minutes.

Match 2: 200 yards, A-21 Target. Unlimited sighters plus 20 shots for record in a block time of 22 minutes.

Match 3: 200 yards, A-21 Target. Unlimited sighters plus 20 shots for record in a block time of 22 minutes.

Match 4: Aggregate of matches 1, 2 and 3.

**Sighting shots may NOT be taken after record fire has commenced. Shooter must notify scorer before the firing of the first record shot that record fire will commence. At the option of the match director, all three matches may be fired in a single block time allotment.*

SCORING: Competitors will be required to score for one other relay. Failure to be prompt for scoring will be cause for disqualification in that match

AWARDS: No cash awards will be given. A fifteen minute bragging rights period will be afforded after the match winners are determined.
